

DATA PROCESSING DECLARATION

I, the undersigned, by signing this declaration, hereby state that pursuant to Article 6 (1) (a) of Regulation (EU) 2016/679 (General Data Protection Regulation – GDPR), as well as Section 5 (1) (b) of Act CXII of 2011 on Informational Self-Determination and Freedom of Information, I consent to the Hungarian Taekwondo Federation processing and using my personal data and data related to examinations in accordance with applicable laws, and furthermore transmitting such data to the Kukkiwon / World Taekwondo organizations for the purposes of examination-related data provision and record-keeping.
